## Special Edition - COI Resources to Support

### Merging Response to Intervention (RTI) with New Priority Areas

Many states, districts, and schools are merging new educational initiatives and priorities, such as **college-and career-readiness** and **School Improvement Grants (SIG)**, with their existing RTI framework as a way to support students with learning difficulties and disabilities. The Center on Instruction has developed a table identifying COI resources on RTI that support these initiatives that includes: (1) resources to support the **state level** implementation of RTI; and (2) resources to support **school and/or district level** implementation of RTI. The support that these COI resources can provide to SEAs, LEAs, and schools in the delivery of effective instruction that promotes mastery of **college-and career-ready standards** includes:

- Design of professional development
- Selection of research-based core instructional programs
- Design, delivery, and use of evidence-based intensive interventions
- Ongoing data-based decision-making
- Differentiation of instruction

Similarly, the **School Improvement Grants (SIG)** turnaround and transformation models include several requirements that link directly to effective instruction and the essential components of RTI, including:

- Design of professional development
- Providing staff with ongoing, high-quality, job-embedded professional development
- Using data to identify and implement research-based instructional programs that align with state standards
- Promoting the continuous use of student data to inform and differentiate instruction
- Establishing schedules and implementing strategies that provide increased learning time

Please note that these resources pertain to systems-level issues (i.e., factors that support the implementation of RTI) rather than effective instructional practices within an RTI framework.
